2018 has been a very busy, but great year for WRWA. Many new installations, repairs, and projects took place throughout the year.

Our newest project we are gearing up for is our water connection to Rathbun Regional Water Association. By 2021, WRWA will be serving all customers south of the Des Moines River with water from Rathbun Regional Water Association. With this change we will be doing several piping upgrades and adding an additional booster station. Our treatment plant will also be ramping up production to supply additional services on the north side of the system.

We are continually looking for ways to improve our system and infrastructure to provide the best service possible to our customers. This includes repairing and installing water lines so we can provide our customers with the highest quality of water possible. If you experience a sudden reduction of water pressure or an interruption in service, please call our office.

We are also pleased to announce that water rates for 2019 will not be increasing.

Friendly Reminders

Wicked winter weather can cause plumbing pipes to freeze and possibly burst, causing flooding and costly water damage to your home. In extreme cases of cold, or if you have had pipes burst in the past, let your faucets run very slowly. This is most effective with faucets that are farthest from the point where the main water line enters the house.

When installing or constructing any new dwellings or structures on your property please be conscious of staying clear of our infrastructure. It is vital that we have access to our property in the event of a repair. If personal property is built over our infrastructure, the owner will be personally responsible for all expenses incurred for the repair.

News from the Construction Crew

2018 was another busy year for installations and repairs to our water service area. With the dry conditions, our construction crew installed a total of 49 services throughout the system. This growth included both new and existing households, along with new livestock services as well.

Along with our new installations, the crew also worked on many repairs throughout the year. Some of those repairs included re-boring 3 different creek crossings that had exposed water main. We would like to send out a special thank you to our customers that reported this exposed main to our office. Without these calls, these mains could go undetected for a period of time which can lead to major issues if not repaired.

Distribution Update


